Behavior Intervention Case Management

The Behavior Intervention Case Manager (BICM) is a designated school professional such as a psychologist, special education teacher, or social worker who has received training in behavior analysis with an emphasis on positive behavior support.

Those who are interested in becoming a BICM for the school site are invited to take a pre-test on the basic principles of behavior development and change and behavior support and behavior intervention approaches. Those who successfully complete this test will be eligible to take the BICM Certification sessions (one set of 5 sessions including the final certification test). Those who are not able to successfully complete the basic information test will be invited to take a behavior management workshop separate from the BICM identification process.
